Thank you for your interest in supporting the Loudoun Lyme 5K to benefit the National Capital Lyme and Tick-Borne Disease Association. We are excited about this second annual event and have a fun day planned for our participants, families and vendors! In addition to the 5K and the 1M fun run, there will be a host of vendors providing food, treats and children's activities. More importantly, there will be an informational fair during which health professionals, veterinarians and others share valuable information about the symptoms of Lyme disease, treatments, and prevention methods.

The goal behind this annual event is to increase awareness of this incapacitating disease that currently afflicts many thousands of Virginians. Each year, the number of reported cases rises and the public needs to become familiar with the early signs of contact, symptoms, the available treatments, prevention and the fact that the effects can be long-lasting and debilitating.

Facts about Lyme disease:

- Lyme disease is a bacterial spirochete, named *Borrelia burgdorferi*, transmitted by ticks and usually accompanied by several co-infections.
- Lyme disease is growing at four times the rate of AIDS and is quickly becoming our nation's most misdiagnosed and fastest-growing infectious disease.
- Estimates state that only one out of every ten cases of Lyme disease is reported and that many people are misdiagnosed.
- Lyme disease may be difficult to diagnose, because the available tests are many and its symptoms mimic those of other disorders like multiple sclerosis, arthritis, chronic fatigue syndrome, lupus and Alzheimer's disease. It can be complicated by other tick borne diseases and underlying chronic illnesses as well.
- Lyme disease can attack virtually any system in the body. Some of the first symptoms may include a flu-like condition, with fever, chills, headache, stiff neck, achiness and fatigue. Other symptoms can include pain in various joints and muscles, neurological problems, heart involvement, changes in vision or hearing, migraines, low-grade fever and other symptoms.
- > Lyme disease in its late stages can be fatal if left untreated.
- In Virginia in 2010, there were 1,245 reported cases of Lyme in 2000 there were just 149 reported cases.
- According to the Centers for Disease Control (CDC), the over 30,000 cases reported nation-wide in 2010 are more likely to only represent between six to ten percent of the actual number of cases.
